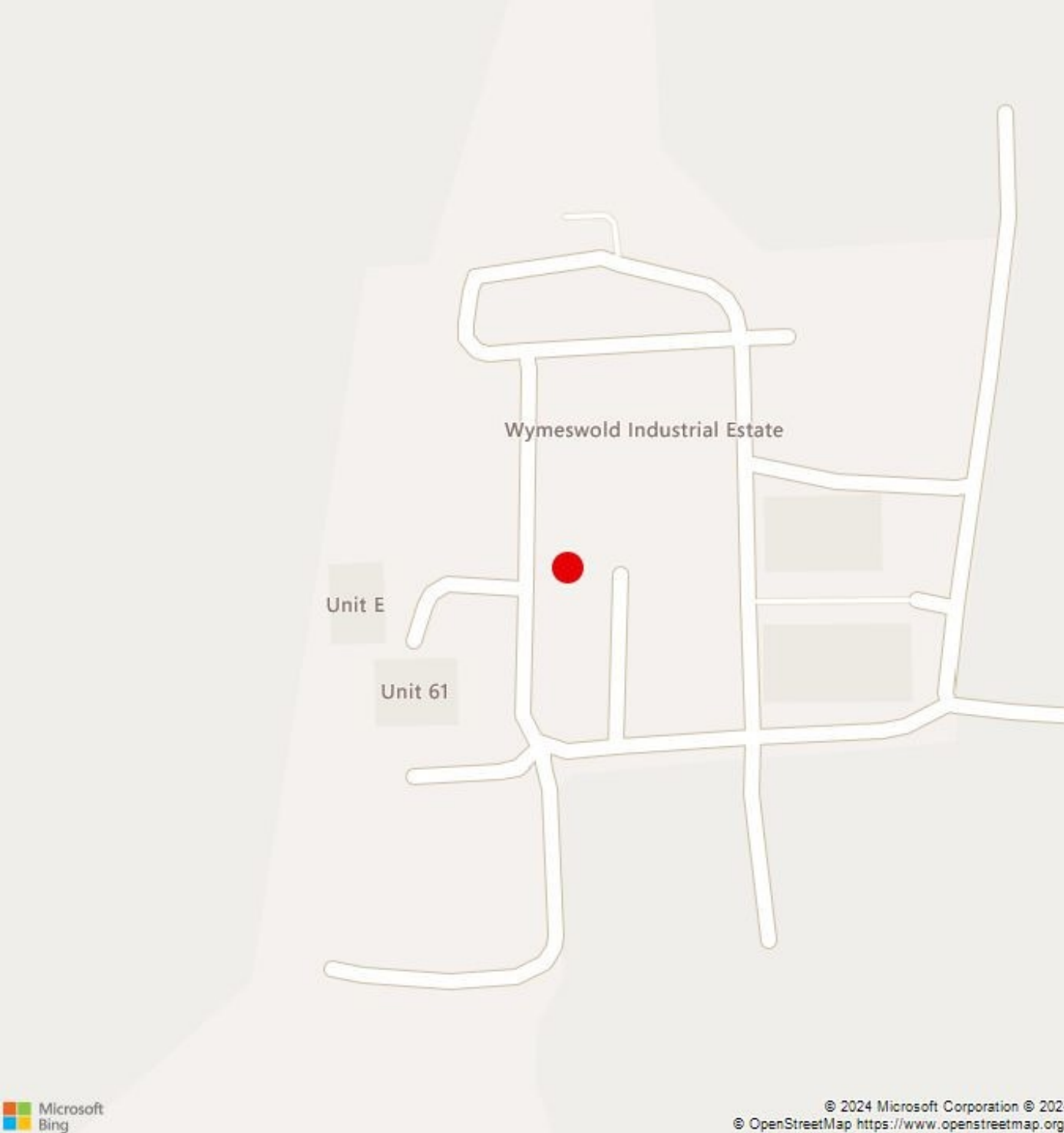

LOCATION

Wymeswold Industrial Park is strategically located midway between the major population centres of Loughborough, Leicester, Nottingham and Melton Mowbray.

The A46 (Six Hills) is situated 3 miles to the east and the A60 is 3 miles to the west.

DESCRIPTION

The property is a mid-terrace industrial unit constructed of brickwork under a pitched plastisol coated steel truss roof.

Access is via double loading doors and internally the property has a solid concrete floor throughout and benefits from w/c accommodation.
