



LOCATION

The property is situated within Pinfold Road Industrial Estate, Thurmaston, which is approximately 3 miles north of Leicester City centre off the A607 (A46 Melton Road), which is a main arterial road leading into the City centre.

The location provides easy access to A46 Leicester western bypass which links with J21 of M1 motorway.

DESCRIPTION

The property comprises of a mid-terrace industrial unit of steel portal frame construction with facing brickwork and a pitched roof.

To the front of the property is a loading door providing access to the main production/warehouse accommodation alongside a personnel door.

The warehouse has the benefit of a solid concrete floor approximately 5.75m to eaves, roller shutter access, 3 phase power and kitchen/WC provision. Externally, there is a large forecourt for parking and loading area suitable for HGV deliveries.
